NOTICE OF SPECIAL ELECTION

Notice is hereby given that a Special Election will be held in the City of Beebe, Arkansas (the "City") on September 14, 2021, at which there shall be submitted to the electors the following questions:

1. The adoption of a 0.25% local sales and use tax within the City, the net collections of which remaining after deduction of the administrative charges of the State of Arkansas and required rebates will be used for fire prevention and firefighting purposes.
2. The adoption of a 0.75% local sales and use tax within the City, the net collections of which remaining after deduction of the administrative charges of the State of Arkansas and required rebates will be used for one or more of the following: (a) to acquire, construct, improve, expand, equip, furnish, operate and maintain park and recreational facilities or community center improvements, or both; and (b) to pay and secure the repayment of bonds approved by the voters issued by the City from time to time to finance park and recreational facilities or community center improvements, or both. The levy of the tax is not dependent on any bonds being approved or issued.
3. The issuance of bonds of the City in one or more series in the maximum aggregate principal amount of \$6,025,000 to finance all or a portion of the costs of acquiring, constructing, furnishing and equipping, a community center and any necessary land acquisition and parking, landscaping, signage, drainage, lighting, road and utility improvements related thereto and, in order to pay the bonds, the pledge as collateral of a 0.75% local sales and use tax levied within the City by Ordinance No. 2021-14, adopted May 24, 2021 (the - Tax") if separately approved by the voters. Collections of the Tax no necessary to pay the bonds may be used for purposes as approved from time to time by the voters. The Community Center is expected to include particularly, without limitation, a gymnasium/basketball court, walking track, banquet center, kitchen facilities, administrative office, bathroom facilities, storage facilities, and game room.

Only qualified electors of the City will have the right to vote and the electors may vote either for or against each question as described above. The election will be held between the hours of 7:30 o'clock a.m. and 7:30 o'clock p.m. on September 14, 2021.

Ordinance No. 2021-19

AN ORDINANCE TO WAIVE THE REQUIREMENT OF COMPETITIVE BIDDING FOR THE PURCHASE OF A NEW TRUCK; AND DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, Arkansas Code Annotated § 14-58-303 require competitive bidding for the purchase by the City of Beebe, Arkansas, of supplies, apparatus, equipment, materials, and services the cost of which is excess of \$20,000.00; and

WHEREAS, the City of Beebe, Arkansas, must have in its possession for use on a daily basis a dump truck with necessary accessories; and

WHEREAS, the City of Beebe, Arkansas, therefore is presently in need of a dump truck, the cost of which may exceed \$20,000.00; and

WHEREAS, it has been determined by the City Council for the City of Beebe, Arkansas, that placing the matter for bid would unduly delay the purchase of the dump truck and would likely result in the City of Beebe not obtaining the best equipment necessary for the purposes needed; and

WHEREAS, the City of Beebe has contracted several suppliers regarding the purchase of a dump truck with the necessary accessories thereon and the City Council for the City of Beebe has determined that there exists one (1) supplier, namely the Henard Utility Products, Inc., which has on hand the specific type of dump truck with necessary accessories needed and wanted by the City of Beebe, Arkansas; and

WHEREAS, it has, therefore, been determined by the City Council for the City of Beebe, Arkansas, that competitive bidding, therefore, is not feasible or practical;

THEREFORE, BE IT ORDAINED by the City Council of the City of Beebe, Arkansas:

1. That it is not feasible or practical to require competitive bidding for the procurement of a dump truck with the necessary accessories from the Henard Utility Products, Inc. by the City of Beebe, Arkansas, as defined by Arkansas Code Annotated § 14-58-303 and as held by the Supreme Court of Arkansas in *Klinger v. City of Fayetteville*, 293 Ark. 128, 732, S.W. 2d 859 (1987).
2. That, therefore, the requirement of competitive bidding for the present procurement by the City of Beebe, Arkansas, of the following equipment:
One (1) New Kenworth T-370 conventional single axle chassis with PACCR PX7 300 hp engine and ALLISON 3500RDS transmission; and One (1) new Hol-Mac Corp Model PAC-MAC KB20H-HJ 1828 Standard body, 28 cubic yard dump body. Total of 20" boom. Hydraulic joystick control, hydraulic oil cooler and tool holder. Rear post strobes. Spring assist tarp. should be, and, the same is hereby waived
3. That the Mayor and Clerk of the City of Beebe, Arkansas, shall have and are hereby given the necessary and requisite authority to contract on behalf of the City of Beebe, Arkansas, of said automobiles and to sign necessary documents on behalf of the City of Beebe, Arkansas, without further action of the Council,
4. That the procurement of the dump truck with accessories is necessary for the health and safety of the Citizens of the City of Beebe, Arkansas, and emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage and approval.

The Pulaski Regional Solid Waste Management District is looking for an Environmental Officer (EO) to investigate, manage, administer, and assist in the eradication of illegal dumping in Pulaski County. Responsibilities will also include complementing and supporting EOs, local law enforcement, and code enforcement authorities in the reporting and eradication of illegal tire-dump sites in the five, regional solid waste management districts that make up the nine-county Inter-District Waste Tire Management Program. The EO will also manage the hauler license program for solid waste hauling certification in Pulaski County. The Pulaski Inter-District is headquartered in downtown Little Rock. The EO will be considered an Independent Contractor and not eligible for benefits. Candidate will be required to sign a terms of service agreement.
