ORDINANCE NO. 2022-0²

AN ORDINANCE ESTABLISHING THE OFFICE OF CITY PROSECUTING ATTORNEY FOR THE CITY OF BEEBE; PRESCRIBING THE DUTIES THEREOF; DECLARING THAT AN EMERGENCY EXISTS; AND, FOR OTHER PURPOSES

WHEREAS, Ark. Code Ann. 14-43-313 provides that the city council will prescribe the duties of the City Attorney by ordinance.

WHEREAS, The City Council did not assign the duties of prosecution in the Beebe Department of the White County District Court to the City Attorney

WHEREAS, There is a need to establish the office of City Prosecuting Attorney.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEEBE, ARKANSAS:

SECTION 1. The office of City Prosecuting Attorney is hereby established

SECTION 2. The City Prosecuting Attorney's responsibilities are:

- A. Prosecute all criminal and civil City of Beebe code violations occurring within the corporate limits of the City of Beebe.
- B. Prosecute all misdemeanor criminal violations occurring within the corporate limits of the City of Beebe.
- C. Prosecute all appeals of code violations and/or criminal violations in the White County Circuit Court.
- D. Advise the police department on legal matters pertaining to the Arkansas Freedom of Information Act when requested
- E. Handle any civil litigation arising from matters involving the Arkansas Freedom of Information Act.
- F. Assist the City Attorney with providing civil defense when requested or when the City Prosecuting Attorney has knowledge relating to the civil claim.

SECTION 3. The City Prosecuting Attorney is permitted to maintain and participate in a private law practice but shall not do so in a manner that conflicts with his or her duties assigned herein.

SECTION 4. The compensation of the City Prosecuting Attorney shall be set by resolution. The City shall provide individual insurance with the option to participate in the family plan provided by Municipal Health Insurance. The City is responsible for all court filing fees, disposition/transcript costs, expert fees, process server fees, postage expenses, all other costs associated with the city prosecuting attorney office shall be negotiated by the Mayor and the City Prosecuting Attorney subject to final approval by a majority of the City Council. A separate agreement prescribing compensation, other fees, expenses and non-statutory benefits to be paid to the City Prosecuting Attorney may be entered into and approved by the Mayor and City Council.

SECTION 6. All reports, records, documents and other materials prepared by the City Prosecuting Attorney in performance of assigned duties shall be the property of the City and shall be delivered to the City upon request.

SECTION 7. The Mayor and or City Council specifically reserve the right to retain outside counsel on all matters at the rate of up to \$250.00 per hour, including civil or criminal litigation.

SECTION 8. The Mayor shall have the power to appoint and remove the City Prosecuting Attorney, both of which are subject to council veto by two-third majority of the local membership of the council.

SECTION 9. All ordinances and provisions therein inconsistent with this Ordinance are hereby repealed.

SECTION 10. This Ordinance being necessary so as to protect the health, safety, and welfare of the citizens of the City, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage.
