

Eagles Soar Past Badgers

BEEBE - On Friday night October 7th, the Badgers went into Homecoming 2022 with high hopes, playing their rival the Vilonia Eagles at Bro Erwin Stadium, Wooten Field. But, the ball bounced the Eagles' way in the end, as the Eagles won the contest, 17-14.

Neither team could hit paydirt in the 1st quarter with both teams having multiple possessions, but each unable to punch it in the end zone. The Eagles started the 2nd quarter on the Badger 15-yard line, after a short drive into Beebe territory to end the first quarter. After several short runs, the Eagles hit on a short pass and run, but the Badger defense would not break and the Eagles attempted a field goal, which was true from 25yards out, at the 9:04 mark of the 1st half. Making the score 3-0 Vilonia. The Badgers took the kickoff at their own 34-yard line and were able to work their way down to the Vilonia 48-yard line, when Zach Grant found Oquoieah Earl on the Eagle 24-yard line with 7:00 remaining in the half. The Badgers ran several rushing plays that were snuffed out by the Eagle defense. On 4th down, Jayden Smith burst up the middle for an 18-yard touchdown scamper and with the extra point, the Badgers led the contest 7-3 at the 4:11 mark of the first

The Badgers kicked off to Vilonia's 40-yard line. The Eagles ran several positive yard runs into Beebe's territory, after a couple of short passes to the Badger 8-yard line, it only took Vilonia 2 plays to hit paydirt on a QB sneak and Vilonia led 10-7 with 2:09 remaining in the half.

On the ensuing kick off, Braden Sanders fielded the ball at the Badger 15-yard line and ran through everyone to the endzone, scoring a Badger touchdown and making the score 14-10 at the 1:54 mark of the first half. Vilonia took the kickoff at their own 35-yard line, after a few quick hitch pass plays, the Eagles threw an interception to Brenton Brasfield on the Badger 10yard line. The Badgers ran out the clock and led 14-10 at halftime.

line. After a 30-yard run by Kiandrea Barker to the Vilonia 46-yard line, with 11:24 remaining in the 3rd quarter, the Badgers looked to be in business again. After a penalty and run for no yards, the Badgers could only get 6-yards on a QB sneak and after an incomplete pass on 4th down, Vilonia took over at their own 40-yard line. The Eagles wasted little time and on first down passed the ball to the Badger 12-yard line. The Eagles could only push the ball to the 4-yard line on 4th down on 4th down the Eagles hit a short hitch into the endzone, with 7:32 remaining in the third quarter, making the score 17-14 Eagles,

Vilonia kicked off to the Badgers - after taking over on their 32-yard line, the Badgers were able to get into the Eagle's territory on several short runs, working their way down to the Eagle 32-yard line on Jayden Smith's 4th down run. After a penalty pushed the Badgers back, Zach Grant was able to hit a seam and run to the Vilonia 24-yard line setting up a 4th and 2 yards to go as the third quarter ended, with Vilonia in the lead 17-14.


The Badgers started on the Vilonia 24-yard line to begin the final stanza - facing a fourth and two. After a false start on the Badgers they faced 4th and 7 yards to go - Braden Sanders was

took over on their own 23yard line with 11:50 remaining in the game. The Eagles began to eat clock with short runs and passes - as they moved up the field into Badger territory. After a personal foul on the Badgers, the Eagles took over on the Badger 20-yard line. The Badger defense came up big again at the 7:09 mark of the 4th quarter, as Braden Sanders intercepted the ball and returned it to the Badgers 40-yard line.

Two plays later - Kiandrea Barker fumbled the ball back to the Eagles on their own 44-yard line with 6:23 remaining in the contest. The Eagles really began to control the clock at this point, with their short run/pass offense. The Eagles worked their way down to the Badger 15-yard line with under a minute remaining. After turning the ball over on downs, the Badgers were unable to move the ball with .22 remaining in the game. The Eagles took home a hard fought victory, 17-14. The Badgers now stand at 4-3 overall and 2-3 in 5 A Central Conference play.

The Badgers will travel to Little Rock and face Joe T. Robinson this Friday Night at JoeT. Robinson High School beginning at 7 p.m.


