ORDINANCE NO. 2022-17

AN ORDINANCE TO AMEND THE ZONING MAP WITH REGARD TO THE ZONING CLASSIFICATION OF SPECIFIED LAND AREA WITHIN THE CITY OF BEEBE, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the Planning Commission for the City of Beebe, Arkansas, has, pursuant to the Beebe Zoning Code and other applicable law, conducted public hearings upon the requested amendment of the Zoning Map heretoofore adopted by the City Council for the City of Beebe, Arkansas, with respect to the hereinafter described lands; and,

WHEREAS, the Planning Commission for the City of Beebe, Arkansas, has conducted said public hearings and fulfilled the Commission's obligations pursuant to federal, state, and local law, whereby the City Council for the City of Beebe may take action on this matter; and,

WHEREAS, the City Council has reviewed the requested zoning changes.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF BEEBE, ARKANSAS:

SECTION 1. The Zoning Map for the City of Beebe, Arkansas, be and is hereby amended for purposes of changing the Zoning Classifications from R-1 Residential to C-2 Commercial as to that real property located in Beebe, White County, Arkansas, which is described as follows:

LOCATION: A part of the Northwest Quarter of Section Eighteen, Township Five North of the Baseline, Range Eight West of the Fifth Principal Meridian, White County, Arkansas, being more particularly described as follows: Commencing at the Northwest Corner of Section 18, T5N-R8W, thence S88° 53' 38" E for 1468.73 feet to the Point of Beginning; thence S00° 45' 00" W for 463.03 feet to a point; thence S89° 05' 33" E a distance of 284.08 feet to an existing 1/2" rebar; thence N 00° 45' 00" E for 462.05 feet to a point; thence N88° 53' 38" W for 284.09 feet returning to the Point of Beginning, containing 3.02 acres more or less. More commonly known as 2001 W. Center Street, Beebe, Arkansas.

EMERGENCY CLAUSE. The regulation and preservation of property uses and values in accordance with a comprehensive plan and the continuing utilization of lands within the City of Beebe in accordance therewith being necessary for the preservation of the public peace, health, safety and welfare, an emergency is hereby declared, and this Ordinance shall be in full force and effect from and after its passage.

AN ORDINANCE AMENDING ORDINANCE NO. 2006-06 AND CHAPTER 14.6, SECTION 14.06.04 OF THE BEEBE ZONING CODE TO INCREASE CERTAIN MINIMUM LOT AREAS AND LOT WIDTHS AT BUILDING LINE IN R-2 AND R-3 DISTRICTS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, pursuant to the Beebe Zoning Code, in R-2 Districts the minimum Lot Area for Single Family Detached and Multi-Family uses are presently 5,000 square feet and the Lot Width at Building Line for Single Family Detached use is presently 50 feet with interior side vards of 8 feet; and

WHEREAS, pursuant to the Beebe Zoning Code, in R-3 Districts the minimum Lot Area for Single Family Detached use is presently 5,000 square feet and the Lot Width at Building Line for Single Family Detached use is presently 50 feet with interior side yards of 8 feet; and

WHEREAS, the Planning and Zoning Commission for the City of Beebe (the "Planning Commission") has met and determined that these minimum Lot Areas should be increased to 6,500 square feet and these Lot Widths at Building Line should be increased to 65 feet; and

WHEREAS, it was been determined by the City Council for the City of Beebe, Arkansas, that the decision and recommendations of the Planning Commission should be accepted and adopted by the City of Beebe.

THEREFORE, BE IT ORDAINED by the City Council of the City of Beebe, Arkansas:

- That Ordinance 2006-06 (and any amendments thereto) and Chapter 14.05, Section 14.06.04 of the Beebe Zoning Code (as amended from time to time) shall be and are hereby further amended as follows:
- In R-2 Districts the minimum Lot Area for Single Family Detached and Multi-Family uses are increased to 6,500 square feet and the Lot Width at Building Line for Single Family Detached use is increased to 65 feet with interior side yards amended to 12 & 8
- In R-3 Districts the minimum Lot Area for Single Family Detached use is increased to 6,500 square feet and the Lot Width at Building Line for Single Family Detached use is increased to 65 feet with interior side yards amended to 12 & 8 feet.
- That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of any conflict.
- That should any portion of this Ordinance be found to be unenforceable, it shall not affect the validity of the remaining portions of the Ordinance.
- It being necessary for the present and future growth of the City of Beebe, Arkansas, to coordinate and harmonize these minimum Lot Areas and Lot Widths at Building Line and for the efficient operation of the municipal government and to preserve the peace, health and welfare of the citizens of the City of Beebe, Arkansas, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage and approval.
