LEGAL NOTICES

ORDINANCE NO. 2023-31

AN ORDINANCE AUTHORIZING THE DESTRUCTION OF CERTAIN BEEBE POLICE RECORDS, DECLARING THAT AN EMERGENCY EXISTS; AND FOR OTHER PURPOSES

WHEREAS, the City Council of the City of Beebe ("City") recognizes that Beebe Police Department is in possession of a large volume of paper records, which are burdensome to store and Arkansas law authorizes the destruction of certain records; and

WHEREAS, the City Council of the City desires to authorize the Beebe Police Department to destroy certain records in accordance with Ark. Code Ann. § 14-2-204.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEEBE, ARKANSAS, THAT:

SECTION 1: Guidelines for destruction of police records.

- a) The Beebe Police Department may, in accordance with Ark. Code Ann. § 14-2-204 and after a period of three years, destroy paper cops of: Accident reports; Incident reports; Offense reports; Fine and bond records; Radio logs and complaint cards; employment records, payroll sheets, time cards, and leave request.
- b) The Beebe Police Department may, in accordance with Ark Code Ann. § 14-2-204 and after a period of seven years from the closure of the case, destroy paper copies of: closed municipal police case files for Class A Misdemeanor offenses, and Expungement orders of municipal police cases.
- c) The Beebe Police Department may, in accordance with Ark Code Ann. § 14-2-204 and after a period of seven years from the closure of the case, destroy paper copies of: closed municipal police case files for felony offenses, excluding sexual offenses and crimes of violence as defined by Ark Code Ann. § 5-42-203 and § 12-12-104.
- d) The Beebe Police Department may, in accordance with Ark. Code Ann. § 14-2-201 et seq., electronically copy and certify records that must be retained pursuant to Ark. Code Ann. § 5-42-203, § 12-12-104 and § 14-2-204. Upon electronic copy and certification, the chief of police may certify the same to the mayor, who may then authorize destruction of the physical records.

SECTION 2: SEVERABILITY. In the event any title, section, paragraph, item, sentence, clause, phrase, or word of this Ordinance is declared or adjudged to be invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of the Ordinance, which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of this ordinance.

EMERGENCY CLAUSE: This Ordinance being necessary so as to protect the health, safety, and welfare of the citizens of Beebe, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage.
