#### **LEGAL NOTICES**

Ordinance No. 12024-18

AN ORDINANCE TO AUTHORIZING THE BEEBE POLICE DEPARTMENT TO IMPLEMENT POLICIES AND PROCEDURES, REPEALING CERTAIN ORDINANCES, DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS: the City of Beebe, Arkansas has previously adopted policies and procedures for its Police Department; and,

WHEREAS: since adoption, many policies have needed revision due to changes in technology, law, and best practices; and,

WHEREAS: the City Council has determined that it is in the best interest of the citizens and police officers of the City of Beebe that the Beebe Police Department have exclusive authority to adopt policies and procedures related to its operation.

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEEBE, ARKANSAS:

Section 1. The Beebe Police Chief is authorized to adopt and implement policies that govern the Beebe Police Department.

Section 2. The Beebe Police Department shall implement a policy requiring its uniformed officers to wear and use body cameras while on duty. Further, the Beebe Police Department shall at all times maintain a policy relating to vehicle pursuits, use of force, racial profiling, and domestic violence. This section in no way limits the type or number of policies that the Beebe Police Department may implement, but rather this list is a minimum requirement.

Section 3. The Beebe Police Department shall continue to adopt policies as needed to ensure the safety of the city's citizens and police officers.

Section 4. Ordinance number 2008-13 is hereby repealed, and any other ordinance that conflicts with this Ordinance shall have no impact on this Ordinance.

Section 5. This Ordinance in no way limits the Beebe Personnel Policy or its application to members of the Beebe Police Department.

EMERGENCY CLAUSE: Maintaining the efficient and smooth operation of the Beebe Police Department is necessary for preserving the public peace, health, safety, and welfare. Therefore, an emergency is hereby declared, and this Ordinance shall be in full force and effect from and after its passage.

AN ORDINANCE TO WAIVE THE REQUIREMENT OF COMPETITIVE BIDDING FOR THE PURCHASE OF A STREET DEPARTMENT VEHICLE; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, Arkansas Code Annotated §14-58-303 require competitive bidding for the purchase by the City of Beebe, Arkansas, of supplies, apparatus, equipment, materials, and services the cost of which is excess of \$35,000.00; and

WHEREAS, the City of Beebe, Arkansas, must have vehicles for street maintenance with necessary accessories in its possession for use on a daily basis; and

WHEREAS, the City of Beebe, Arkansas, therefore is presently in need of a pickup truck (the "Vehicle") to be accessorized for services, the cost of which may exceed \$35,000.00; and

WHEREAS, it has been determined by the City Council for the City of Beebe, Arkansas, that due to the limited in supply stock placing the matter for bid would unduly delay the purchase

of the Vehicle and would likely result in the City of Beebe not obtaining the best vehicle necessary which could be accessorized for the purposes needed; and WHEREAS, the City of Beebe has contracted several suppliers regarding the purchase

of the Vehicle and the City Council for the City of Beebe has determined that there exists one (1) supplier, namely Red River Ford, located in Cabot, Arkansas, which has on hand the specific type of vehicle which can be accessorized as needed and wanted by the City of Beebe, Arkansas;

WHEREAS, it has, therefore, been determined by the City Council for the City of Beebe, Arkansas, that competitive bidding, therefore, is not feasible or practical;

THEREFORE, BE IT ORDAINED by the City Council of the City of Beebe. Arkansas:

1. That it is not feasible or practical to require competitive bidding for the procurement of a Vehicle from the Red River Ford by the City of Beebe. Arkansas, as defined by Arkansas Code Annotated § 14-58-303 and as held by the Supreme Court of Arkansas in Klinger v. City of Fayetteville, 293 Ark. 128, 732, S.W. 2d 859 (1987).

2. That, therefore, the requirement of competitive bidding for the present procurement by the City of Beebe, Arkansas, of the following equipment:

One (1) New 2024 Ford Super Duty F-250 SRW, Crew Cab Pickup, as set forth in more detail in the Invoice attached hereto and incorporated collectively herein as Exhibit "1".

should be, and, the same is hereby waived

That the Mayor and Clerk of the City of Beebe, Arkansas, shall have and are hereby given the necessary and requisite authority to contract on behalf of the City of Beebe. Arkansas, of said Vehicle and to sign necessary documents on behalf of the City of Beebe, Arkansas, without further action of the Council,

That the procurement of the Vehicle is necessary for the health and safety of the Citizens of the City of Beebe, Arkansas, and emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage and approval.


